From I-85 South (Traveling Towards Atlanta):

Get off the interstate at Exit 51 and turn left towards Auburn. Proceed approximately 1.5-2 miles to the intersection with Shug Jordan Parkway/University Dr. and turn left.

Follow Shug Jordan Parkway for about 3.5 miles to Richland Rd. It is the first left after the intersection with Hwy 14. You will see a green and white sign directing you to the turnoff to the Yarbrough Tennis Center. Turn left onto Richland Road and proceed about 0.5 mile. The Yarbrough Tennis Center is on the left.
